ARCHITECTURAL AMENDMENTS TO YOUR HOME

Every resident who moves into and lives in Forest Lakes is held to the rules and regulations set forth in the Resident Guidelines. These guidelines can be found on our website at www.forstlakes.net. Anyone wishing to make external changes to their property must meet the Resident Guidelines and submit an application (also available on the website or in the FLCA office) before initiating work. The most common changes are fences, storage sheds, tree removal, door and shutter color changes, home additions and solar panels. The application is then review by the ARB. The integrity and beauty of surrounding neighborhoods is maintained by adhering to the policies of the ARB Resident Guidelines. Thanks for your cooperation!

ASHWOOD BOULEVARD CLOSURES

The entrance to Forest Lakes South at Ashwood Boulevard may continue to be closed during the second week in February 9 p.m. and 6 a.m. while a new water line is installed across the intersection. Please watch the VDOT signs for the most up-to-date information.

The water main relocation is part of the Route 29 widening project under construction by Lane-Corman Joint Venture. The work, which is being coordinated with the Rivanna Water and Sewer Authority and the Albemarle County Service Authority, will upgrade the distribution system by replacing an aging 12-inch water main with the new 24-inch main running along the east side of Route 29.




FEBRUARY IS **FENCE** MONTH IN FOREST LAKES!



For residents with fences, this is a great month to go out and inspect your fence. Is it in need of repair? Are the posts and rails in good condition? Is the gate secure? Contractors tend to be less busy this time of year – a great time to call one up and have your repairs made now. Help keep your yard and Forest Lakes looking its best.

Some Forest Lakes Fence Facts:

- An Architectural Review Board form MUST be filled out when you are planning on putting a fence in your back yard.
- All fences in Forest Lakes must be natural wood, split rail (except for within some of our sub associations).
- Fences must be within 2 feet of your property line or 1 foot from common area, and cannot be "shared" with your neighbor's fence.
- Privacy is not a reason for fencing those issues should be address with shrubbery and landscaping.

Dear Forest Lakes Residents,

I can only hope that we can get as "warm" as we were in February as we were this past month. Despite a few unplayable days with snow and cold temperatures, January wasn't that bad for tennis play at Forest Lakes.

Despite that the calendar says it's February, I am very optimistic that we can get out and play a lot this month too.

On Mondays, and Thursdays I have been conducting the Adult "Co-ed" Clinic, from 6-7:30 pm. That will continue in February. On Tuesdays, 6-7:30 pm, I will continue to coach a Women's Team Practice. On Wednesdays, 6-7:30 pm, the Women's Night Workout will endure when conditions permit. Forest Lakes residents are urged to sign up for these clinics via text or email.

"When conditions permit" means if the temperatures are around 45 degrees or better, no snow on the courts, and not raining. The Clay Tech courts at the Forest Lakes North facility do very well in the winter. Following a snow melt, or a little rain, the courts are in awesome condition for play. (As always, if there is standing water on the Clay Tech courts, don't play!)

If the Clay Tech courts are too dry, I conduct my lessons at the Forest Lakes South facility. For up-tothe-minute court conditions, and clinic and lesson status, I will email and/or text those that have signed up with me.

Looking ahead to March... the After School Junior tennis program begins! The program goes for ten weeks, with a five-week option also available. Your child can choose to play one- two- or three-times per week. The information and sign-up sheets are available at the FLCA office, on the FLCA website, and at the Pro Shop.

Finally, the USTA leagues will commence a little earlier this year. A mid-March start is anticipated. Once the leagues start, it is a good idea to book your court on the reservation sheets provided at the Pro Shop for the North courts, and at Court One at the South courts.

Until then, I look forward to seeing you on the courts.

Beginners I, II and III (Guidelines) Player has little or no experience. Beginner I is for very young players, Beginner Il is for slightly older beginners. Beginners III is for beginners that are 12 or older.

Advanced Beginner (Guidelines) Player must be able to hit 10 balls in a row against backboard from 20 feet away (forehand & backhand), rally with partner from the baseline 10 balls in a row each, serve 5 of 10 balls into appropriate service box, know how to keep score, and play a complete tennis match.

Intermediate (Guidelines) Player must be able to hit 20 balls in a row against backboard from 20 feet away (forehand and backhand), rally from baseline with partner 30 balls in a row, serve 6 of 10 serves to each service box, and must have played at least 5 complete tennis matches. Player must exhibit proper stroke mechanics and grips for all shots and must know the rules of tennis.

Tournament Training (Guidelines) Player must be able to maintain a baseline rally of 40 balls, properly execute volleys and overheads, and be able to execute flat, slice and kick serves. Players should also be training for high school or tournament competition.


